Hello Kindred Residents:

This letter is to provide information about the sewer rate change and to inform you of rate increases to the sewer base rate and the sewer usage rate, in addition to the new 2019-1 Wastewater Collection Improvement Project charge.

The increased rates, provided on the back page of this letter, represent MOST City of Kindred sewer rate users. (Commercial, high-volume users, multi-family units, apartments, and rural subdivision rates may vary from the rates illustrated on the back page.)

The 2019-1 Wastewater Collection Improvement Project charge is a new addition to all sewer users' monthly City of Kindred Utility Bill effective January 1, 2022. This is required to help pay for the loan of the Wastewater Collection Improvement Project that is currently under construction. This will be a monthly fee of \$22.09 per user.

The increase in the sewer base and usage rate, in addition to the new project charge, was approved at the November 3, 2021 City Council meeting.

Sewer Rate - CHANGE Effective January 2022

Information

Utility Billing Adjustments

The City of Kindred has implemented changes to Utility Billing, most notably an increase in monthly sewer charges. These adjustments will be implemented with the January 2022 Utility billing cycle. (See chart below for details.)

What is Changing

The minimum monthly base rate charge and the monthly usage charge for sewer service will be increasing. There will also be a new charge for the New Wastewater Collection Improvement Project loan labeled "2019-1 Wastewater Project."

Why It's Needed

The current lagoon system has required minimal funds for operations and maintenance, thus resulting in rates that have not increased since 2011. As our community and infrastructure needs have grown, the increased rates will better align with the city's increasing sewer expenses.
